BE IT KNOWN that I also give my consent for the above-named student to accompany the team as a member on its out-of-town trips. I understand that, on some occasions, coaches will allow athletes to ride with the parent/guardian of other team members to and/or from athletic events in privately-owned cars.

IT IS FURTHER understood that I agree to pay a one-time per school year fee of \$25 for insurance with the understanding and acceptance that the insurance is a secondary policy per coverage.

CONSENT for MEDICAL TREATMENT

I recognize that medical treatment on an emergency basis may be necessary as a result of athletic participation, and further recognize that school personnel may be unable to contact me for my consent for emergency medical care. My signature below attests that I do hereby consent in advance to such emergency care, including hospital care, as may be deemed necessary under the then-existing circumstances and to assume the expenses of such care, and allow all medical information to be released and/or reviewed by Kalamazoo Central High School, and for consent to disclosure to the MHSAA of information otherwise protected by FERPA and HIPAA for the purpose of determining eligibility for interscholastic athletics.
